Dear Sir,

This is in continuation of our letter dated 10 February 2020 forwarding therewith a copy of Postal Ballot Notice and explanatory statement, seeking the consent of the shareholders by way of Special Resolution, through Postal Ballot / electronic voting, in due compliance of the provisions of Section 110 of the Companies Act, 2013, as amended, with respect to **limiting the Foreign Portfolio Investors'** (FPI) investment at 24% of the equity paid up share capital of the Company.

In the above context, pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that Shri Shyamprasad D. Limaye, Practising Company Secretary, the Scrutinizer appointed for conducting the postal ballot process, has submitted his report to the Chairman of the Company and the results of Postal Ballot have been announced by him today i.e. on 12 March 2020, in terms of which, the above resolution has been passed by the members with requisite majority.

Scrutiniser's Report

[Pursuant to Section 110 of the Companies Act, 2013 and Rule 20 and 22 of the Companies, (Management and Administration) Rules, 2014, as amended]

To,

Dear Sir,

- I, Shyamprasad D Limaye, a Company Secretary in practice, have been appointed by the Board of Directors of Maharashtra Scooters Limited ("the Company") as a scrutiniser for the purpose of scrutinising the postal ballot forms and e-voting and ascertaining the requisite majority on voting carried out as per the provisions of Section 110 of the Companies Act, 2013, read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, on the resolutions contained in the postal ballot notice dated 28th January, 2020 ("the resolutions").
- 2. The notice dated 28th January, 2020, seeking approval of members of the Company along with statement setting out material facts under Section 102(1) of the Companies Act, 2013 was sent to the members in respect of the resolutions to be passed, through postal ballot. The Company had also provided remote e-voting facility to the members to vote on the resolutions through the electronic voting platform provided by KFin Technologies Private Limited ("K-Fin").
- 3. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through postal ballot/remote e-voting on the resolutions for approval of the members of the Company. My responsibility as a Scrutinizer for the postal ballot forms and remote e-voting is restricted to make a Scrutinizer's report of the votes cast in "favour" or "against" the resolutions and "invalid" and "abstained" votes, based on the postal ballot forms received and the reports generated from the e-voting platform provided by KFin.
- 4. Further to the above, I submit my report as under:
 - i. The Company has completed dispatch of Notice on Saturday, 07th February, 2020:
 - a. dispatch of postal ballot notice and ballot form along with postage prepaid business reply envelope to its members whose names appeared in the register of members/list of beneficial holders as on Friday, 31st January, 2020, (End of Day) through speed post to the members who have not registered their email ID.
 - b. dispatch of postal ballot notice and ballot form to its members whose names appeared in the register of members/list of beneficial holders as on 31 January, 2020 (End of Day) through email at their registered email ID.



- c. The remote e-voting period remained open from Monday, 10th February, 2020 at 9.00 a.m. to Tuesday, 10th March, 2020 at 5.00 p.m.
- The members whose names appeared in the register of members as on the "cut-off date i.e. Friday, 31st January, 2020, (End of Day) were entitled to vote on the resolutions as set out in the Postal Ballot Notice of the Company.
- iii. The remote e-voting facility was blocked on Tuesday, 10th March, 2020 immediately after the completion of voting hours in the presence of 2 witnesses, Mr. Neelkanth G. Limaye and Mr. Mayur M. Kulkarni who are not in the employment of the Company.
- iv. The postal ballot forms were kept under my safe custody in sealed and tamper proof envelopes before commencing the scrutiny of such postal ballot forms.
- v. All postal ballot forms received up to Tuesday, 10th March, 2020, being the last date fixed by the Company for the receipt of the forms, were considered for my scrutiny. Envelopes received after Tuesday, 10th March, 2020, were not considered. All votes cast on KFin e-voting platform up to 5.00 p.m. on Tuesday, 10th March, 2020, were considered for my scrutiny.
- vi. The postal ballot forms which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- vii. Particulars of all the postal ballot forms received from the members by Tuesday, 10th March, 2020, are manually entered on the system provided by KFin.
- viii. A total of 389 envelopes containing postal ballot forms were returned undelivered. These envelopes are not opened and are kept separately.
 - ix. Thereafter considering votes through remote e-voting and votes cast through postal ballot forms, the combined result of the voting is given below. The details containing, *inter alia*, votes cast in "favor "or "against" on the resolutions that were put to vote, and whose votes became invalid and number of votes abstained from voting, were generated from the e-voting website of KFin -i.e. https://evoting.karvy.com and my report is based on such reports generated.
