




BAJAJ AUTO STARTS ANTI-PIRACY CAMPAIGN AGAINST...

In October & November 2010, Police Raids were conducted on few automobile spare parts shops in Nana peth, Pune & Balaram street, Mumbai, which were packing/selling counterfeit parts of Bajaj spare parts packed in non-genuine packing.
