⁵ As specified in Public Announcement. Represents less than 25% of the total paid-up capital of the Company prior to the Buyback as on March 31, 2022, in terms of Equity Shares. The proviso to Section 68(2)(c) of the Companies Act, 2013, as amended, and Regulation 4(i) of Buyback Regulations state that the buyback of equity shares in any financial year shall not exceed 25% of the total paid-up equity share capital of the Company in that financial year. The indicative maximum number of Equity Shares to be bought back at the Maximum Buyback Size and the Maximum Buyback Price is 54,34,782 Equity Shares, which is 1.88% (i.e. less than 25%) of the total paid up equity share capital of the Company. If the Equity Shares are bought back at a price below the Maximum Buyback Price, the actual number of Equity Shares bought back could exceed the indicative maximum number of Equity Shares that can be bought back (assuming full deployment of Maximum Buyback Size) but will always be subject to Maximum Buyback Size.
